## DESCRIPTION

Children's stretchy cotton trousers made of a special Amalytton® material, which ensures increased strength and durability of the cotton fabric while maintaining the comfort of elasticity and all the benefits of the natural material, such as breathability and a pleasant feeling when worn. Extra durable super elastic material Tabiflex® is used on exposed parts. The trousers have a highly ergonomic and functional SLIM FIT cut, which emphasizes the silhouette, including an anatomically shaped knee design for maximum of movement adaptability. The knee area is doubled with a durable Oxford material with a water-repellent finish. The trousers have an adjustable waist width and are equipped with many useful pockets. The back part is divided by the saddle and 2 pockets, the right back pocket is covered by flap with rivet. The bottom hem of the trousers is reinforced with Oxford material against abrasion. Increased safety is ensured by reflective stripes located on the front and back and hi-vis accessories. The trousers allow easy length extension by 5 cm.
