# ArtiVit syrup

VITAR Veterinae ArtiVit Syrup contains substances that are crucial for the nutrition of joints. Since it is a syrup, animals consume it easily, even if dosage is given for a long period. Cats and dogs accept it without issue.

It boasts five core mechanisms for the following benefits:

1. Nutrition of joints and joint capsules (glucosamine sulphate 2KCl and chondroitin sulphate)
2. Anti-inflammatory properties (MSM – methylsulfonylmethane)
3. Lubrication of joints and joint capsules (hyaluronic acid)
4. Restores damaged cartilage (hydrolysed collagen)
5. **Pain relief (*boswellia serrata*)**



### Recommended doses:

Small and medium dog breeds of up to 20 kg	5 ml/day
Medium and large dog breeds of 20-40 kg	10 ml/day
Large dog breeds of 40-60 kg	15 ml/day

Standard dose: 5 ml per 20 kg of body weight  
Dosage for cats: 5 ml in total, split over three doses per day.

MSM (methylsulfonylmethane)	50 mg	1000 mg
Hydrolysed collagen	700 mg	14000 mg
Extract of boswellia serrata	20 mg	400 mg
Hyaluronic acid	7 mg	140 mg

Measuring cup included.

1000 ml bottle: Each press of the pump dispenses 5 ml.

**Available in sizes 200 ml, 500 ml and 1000 ml**

### As a preventive measure:

Suitable for cats and dogs from 4-5 years of age, with long-term use for large and heavy dog breeds; those that do regular physical exercise (e.g. canicrossing and agility); rapidly growing puppies; and animals with obesity. Administer for 3 months followed by a month's pause in treatment.

### For therapeutic treatment:

Suitable for animals that have undergone orthopaedic surgery, and for those diagnosed with conditions such as hip dysplasia or osteoarthritis. Applicable for painful conditions affecting locomotion. Can be administered continuously.
